



NEW COVID PROTOCOLS

Updated – April 2022 v.8



We are constantly reviewing CDC guidance and watching the current covid trends in the location city, including: Community Level by County, Daily new cases, Infection rate, and Positive test rate. Every shoot has it's own unique set of circumstances, and each location will be analyzed individually. Here are our general guidelines moving forward.



ALL ATTENDEES WILL RECEIVE A COVID TEST. The type of test may vary from shoot to shoot, from client to client, depending on company policies or client's level of comfort and precaution. We may use PCR, NAAT, or Antigen tests. Tests will be taken within 48 hours of appearing on set. You may also be asked to show your CDC vaccination card.



MASKS ARE NOW OPTIONAL FOR OUTDOOR SHOOT.

Anytime we're working on an outdoor production, it is your choice whether to wear a mask or not. If you're doing work outside while the shoot is happening indoors, you may choose.



MASKS ARE REQUIRED FOR INDOOR SHOOT. That includes locations like:

houses, retail stores, small businesses, offices, and while inside a motorhome. Larger spaces such as warehouses, enterprise sized offices, big-box stores, etc will be qualified on a case by case basis.



WHEN THERE ARE CHILDREN ON SET, INDOORS: all crew, clients, models, and the children will be required to wear a mask, as people under 5 years old are not able to receive a vaccine at this time. If the shoot is outdoors, vaccinated people may optionally wear a mask unless in close proximity to children.



We expect that you will continue to practice **GOOD HYGIENE**, including washing your hands frequently, especially when you are near food and drink items. We will continue to provide hand sanitizer and single-serving snacks/drinks/crafty.



If you feel **SICK** or **FEVERISH**, please do not come to work. Refer yourself to a doctor as needed.



There may be higher requirements in place by state, county, or local government officials, including but not limited to: all people wearing masks, covid testing for all crew+cast+clients, and a covid compliance officer to be present. The location at which we are shooting may have requirements as well. Our Clients may also require their own safety measures, which we are always happy to abide by.



For the purposes of this guidance, people are considered fully vaccinated for COVID-19 ≥ 2 weeks after they have received the second dose in a 2-dose series (Pfizer-BioNTech or Moderna), or ≥ 2 weeks after they have received a single-dose vaccine (Johnson & Johnson [J&J]/Janssen) \pm ; there is currently no post-vaccination time limit on fully vaccinated status. Unvaccinated people refers to individuals of all ages, including children, that have not completed a vaccination series or received a single-dose vaccine.
